When Can You Expect Us to Ease Restrictions?

While much of the community and the State of Maryland begin to reopen, we remain conservative and cautious in our approach to easing restrictions in the Health Care Center and Assisted Living and will continue to follow direction from State and County health agencies:

“Certain restrictions that have been enacted at Maryland nursing homes will need to remain in place for the foreseeable future and will not be relaxed at any phase of the reopening process,” says the Maryland Department of Health. “However,

relaxations will take place under certain circumstances while adhering to implemented restrictions. We are grateful for everyone support and patience as we navigate our new normal. More updates to come soon!”

COVID-19 Update

Currently at Miller’s Grant, there are:

Staff Positive Cases: 6

Staff Deaths: 0

Resident Positive Cases: 3

Resident Deaths: 1

These are cumulative numbers. Of these:

- 6 team members testing positive have recovered and returned to work.
- 2 residents in independent living are recovered and beyond the 14 days of quarantine.
- 1 resident in independent living testing positive is receiving medical treatment.

Reminder: If you are not feeling well or experiencing any of the following symptoms, including vomiting, diarrhea, chills, muscle pain, headache, sore throat, new loss of taste or smell, fever, cough or shortness of breath, please contact your nurse.
